

MINUTES OF A SPECIAL PUBLIC MEETING
JULY 24, 2013

The Hollywood Park City Council met in a Special Public Meeting on July 24, 2013 at 3:00 p.m. in Town Hall #2 Mecca Drive, Hollywood Park, TX. 78232. Notice was posted in accordance with the Texas Open Meeting Laws.

Mayor Ortega called the meeting to order with the following Council Members present: Sudie Sartor, Chris Fails and Holly McBrayer. Special guest: Mayor Gabriel Durand-Hollis from Hill Country Village. Mayor Ortega also introduced: Ron Smith and John McFarland from the EPA and Justin Hamm from the Federal Highway Administration all on teleconference. Former Mayor Bob Sartor, Sal DeoCampo-FHA, Doug Booher-TXDOT, Vicki Crnich-TXDOT, Jimmy Robertson-Jacobs Engineering, Clayton Ripps-TXDOT and Renee Green-Bexar County.

Discussion was based on the following:

TO COORDINATE [AS REQUIRED BY STATE AND FEDERAL LAW] WITH TEXAS STATE AGENCIES AND UNITED STATES FEDERAL AGENCIES REGARDING CRITICAL HIGHWAY ISSUES INVOLVING US 281 AND LOOP 1604 IN THE VICINITY OF HOLLYWOOD PARK AND HILL COUNTRY VILLAGE. IN PARTICULAR, COORDINATION WILL OCCUR RELATING TO THE CONSTRUCTION, FINANCING, MAINTENANCE, PROPOSED ADJUSTMENTS, CONCERNS, POTENTIAL LOSS OF CITY REVENUES, POTENTIAL INFRASTRUCTURE DEGRADATION, POTENTIAL ISOLATION OF TOWN CITIZENS AND BUSINESSES, AND THE EFFECT ON THE STREETS, UTILITIES, EDUCATIONAL SERVICES, RECREATIONAL SERVICES AND OTHER ESSENTIAL FACILITIES FOR THE TOWN.

There was discussion and questions among the representatives of Hollywood Park, Hill Country Village, the 391 Commission, the citizens and State and Federal agencies.

Requested documentation for the record is attached along with the list of residents that voiced their opinion through email and those that attended the meeting.
