Committee Chair LuAnn Montgomery called the meeting to order. Committee Members present were LuAnn Montgomery, Barbara Schmitz, Randy Tomasini, Tonya Cummings and Debbie Trueman. Nancy Swan, Carol Ingham, Mike Crevoisier and Reid Loehman were absent. Larry Morris has resigned from the Committee, so the five present constituted a quorum. Attorney Artin DerOhanian and City Secretary Janice Alamia were also in attendance.

APPROVE MINUTES OF AUGUST MEETING Randy Tomasini made a motion to accept the Minutes of the Deer Committee Meeting of August 8, 2016, as submitted, and Barbara Schmitz seconded the motion. The motion passed unanimously, with Tonya Cummings abstaining since she was not at that meeting.

Aug. 12 & 17	500 Block Ventura	Fawn with injured back legs; still mobile.
Aug. 18	100 Block Canyon Creek	Dead deer in yard; appears eaten by coyote; brain stem removed for CWD testing.
Aug. 23	500 Block Ventura	Dead fawn; same fawn as Aug. 12 & 17 reports.
Aug. 29	300 Block El Portal	Dead fawn, unknown reason.

Tonya Cummings made a motion to approve the Wildlife Incident Reports as presented, and Barbara Schmitz seconded the motion. The motion passed unanimously.
