- 1. Fire Report: Chief Butrico gave his monthly report to the Council and again discussed the Santa visits.

NEW BUSINESS:

- 1. <u>Discuss /Take Possible Action to approve a contract with Bexar County to use</u> Hollywood Park as a satellite office to provide vehicle registration stickers.
 - a. Citizen Comments: None
 - b. Discussion: Mayor Fails stated we were waiting on Bexar County to send us a contract in which we would be able to provide vehicle registration stickers to our residents instead of having to go downtown or elsewhere. The contract has not arrived so Mayor Fails tabled this issue.
- 2. <u>Discuss /Take Possible Action to change fees in the Hollywood Park Building Permit Fee Schedule</u>
 - a. Citizen Comments: None
 - b. Discussion: City Secretary, Janice Alamia spoke about the building permit fees in the Council packet. She stated that the building permit clerk, Dara Ford had done a survey of the surrounding cities and proposed we re-evaluate our current fee schedule. The Council rejected the increase of permit fees for residential buildings, because they did not want to place an additional cost burden on residents. The Council accepted the proposed increases in commercial building permit fees, since these projects entail more extensive efforts on the part of the City. The Council also approved proposed penalties for work done without a permit. Councilwoman Debbie Trueman made the motion to accept the new fee schedule as modified and Councilman Cullen Schwarz seconded. The motion passed unanimously.
