

ORDINANCE NO. 1003

AN ORDINANCE OF THE TOWN OF HOLLYWOOD PARK, TEXAS, AMENDING CHAPTER 46, PEDDLERS, CANVASSERS AND SOLICITORS, OF THE CODE OF ORDINANCES, BY REPEALING SECTION 46-4 A AND ADOPTING A NEW SECTION 46-4 A CONCERNING FEES, AMENDING 46-8 C TO SUBSTITUTE THE MAYOR FOR THE CITY MANAGER, AND ADOPTING SECTION 46-18 REGARDING CONTRACT STANDARDS AND RENUMBERING CURRENT SECTIONS 46-18 TO 46-19 AND CURRENT SECTION 46-19 TO 46-20.

WHEREAS, Ordinance No. 1002 regulating peddlers, canvassers and solicitors was adopted by the City Council on June 19, 2018; and

WHEREAS, the City Council desires to adopt certain clarifications for the fee schedule and the City Official responsible for hearing appeals and to add a transparency provision for contracts submitted to residents.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF HOLLYWOOD PARK, TEXAS that Chapter 46, Peddlers, Canvassers and Solicitors of the Code of Ordinances of the Town of Hollywood Park is hereby amended by repealing Section 46-4 A and adopting a new Section 46 A as follows:


A. The fee for each individual peddler shall be \$300.00 per year plus a pass-through charge for each background search (\$25.00 in 2017 – subject to change). If a merchant seeks Peddler’s Licenses for multiple peddlers, the \$300.00 annual fee for each individual peddler shall be charged. For example, if a merchant seeks Peddler’s Licenses for five peddlers, the annual fee will be \$1500.00 plus the pass-through charge for each background search.

NOW, THEREFORE, BE IT FURTHER ORDAINED BY THE CITY COUNCIL OF THE TOWN OF HOLLYWOOD PARK, TEXAS that Chapter 46, Peddlers, Canvassers and Solicitors of the Code of Ordinances of the Town of Hollywood Park, is hereby amended by substituting the Mayor and deleting the City Manager from all references in Section 46-8.

NOW, THEREFORE, BE IT FURTHER ORDAINED BY THE CITY COUNCIL OF THE TOWN OF HOLLYWOOD PARK, TEXAS that Chapter 46, Peddlers, Canvassers and Solicitors of the Code of Ordinances of the Town of Hollywood Park, is hereby amended by adopting the following the new Section 46-18 in the place of the current Section of 46-18 and renumbering the current Section 46-18 as Section 46-19 and the current 46-19 as Section 46-20, as follows:

Sec. 46-18 Contract transparency. A peddler shall furnish to a customer a printed, signed copy of any agreement for the purchase of goods or services sold by the peddler to the customer clearly showing the final total price which the customer is committed to pay. The agreement furnished by a peddler to a customer shall also clearly state any cancellation privileges available to the customer.
