MINUTES OF A REGULAR COUNCIL MEETING JULY 16, 2019

The Hollywood Park City Council met in a regular session on July 16, 2019 at 6:00p.m. in Town Hall. Notice was posted in accordance with the Texas Open Meeting Laws.

Mayor Chris Murphy called the meeting to order with the following Council Members present: Mike Howe, Debbie Trueman, Oscar Villarreal, Delaine Hall and Scott Bailey. Also present: Police Chief- Shad Prichard, Fire Lt.- Tim Zelenak, Public Works Director-Kelly Cowan, City Treasurer- Jeff Hinson, Interim City Attorney- Ryan Henry and City Secretary-Janice Alamia.

PRESENTATIONS:

ANNOUNCEMENTS/ MAYOR AND CITY EMPLOYEES:

- 1. Fire Report: Lt. Zelenak presented his report to council stating he had 49 calls for the month. He also recognized firefighters Jeff Froboese and Bryan Rychlik for their help in recent structure fires per interlocal agreement. Councilmember Hall asked to have an Executive Session at the next Council meeting to discuss the Fire Department schedule and Councilmember Trueman agreed.
- 2. Police Report: Chief Prichard presented his report to council stating he had 396 calls for service for the month.
