OPTION B - Initial: ______, *I do not agree to limit the scope of my request.* I want all available documents regardless of whether the City considers the information to be confidential or subject to being excluded. I understand that the City has the duty to seek an opinion from the Texas Attorney General's Office, Open Records Division which will consist of the following:

- 1. A written request for an opinion from the Texas Attorney General by the City with in ten (10) business days (excluding weekends & holidays recognized by the City) from the date that the City received my initial request;
- 2. A written brief sent to the Texas Attorney General's Office within fifteen (15) from the date that the City received my initial request;
- 3. I might receive a request for clarification of my request if it is vague and ambiguous which will toll (postpone) the deadline for the City's request for an opinion from the Texas Attorney General's Office,
- 4. A waiting period of up to forty-five (45) days for the Texas Attorney General's Office to render an opinion from the date they receive the written brief. I understand that until an opinion is rendered the City cannot fully respond to my request until a final decision is made by the Texas Attorney General's Office regarding my request. I understand that the Texas Attorney General may rule that the information can or cannot be released and I understand that the City may disagree with the opinion provided by the Texas Attorney General's Office. In such cases, the City may seek a decision from a Travis County District Court or higher court, before records are released.

This is a double-sided request from; both sided must be completed (continued on reverse side).

I understand that the documents/information held by a Court, whether a Justice Court, City Court, or District Court are Judicial Records and are not subject to disclosure pursuant to the Texas Public Information Act. Any request for records made for judicial records will be handled pursuant to the Judicial Records Act and will not be considered a request pursuant to the Texas Public Information Act.
