MINUTES OF THE TOWN OF HOLLYWOOD PARK REGULAR CITY COUNCIL MEETING ON TUESDAY, OCTOBER 18, 2022, AT 6:00 P.M.

I. CALL TO ORDER

Mayor Moore called the meeting to order 6:00 p.m.

- **1.** Fire Department monthly report
 - Fire Chief Butrico reported 62 calls for service in September. Chief Butrico announced the Santa Parade on December 17.
- 2. Police Department monthly report
 - Chief Prichard reported 482 calls for service, 504 total citations, and discussed the recent homicide and the success of National Night Out.
- 3. Public Works Department monthly report
 - Kelly Cowan reported 21 Voigt Center rentals, 90 code enforcement cases, updates on Voigt Center rentals and street maintenance, and introduced Orlando Casas.
- **4.** Finance monthly report by City Treasurer
 - City Treasurer Fred Timmons provided an overview of revenues and expenditures.
