Mayor Pro Tem Pearce moved to keep the City Secretary's salary at \$91,052 approved at budget. Councilmember Kounse seconded the motion which failed 2-3, with Councilmembers Drash, Randol, and Gonzalez opposed. Mayor Pro Tem

Pearce moved to keep the Police Chief's salary at \$120,000. Councilmember Kounse seconded the motion which passed unanimously. Mayor Pro Tem Pearce moved to keep the Fire Chief's salary at \$120,000. Councilmember Kounse seconded the motion which passed unanimously.
