

ORDINANCE NO. 2077

AN ORDINANCE MAKING APPROPRIATIONS FOR THE VARIOUS FUNDS AND PURPOSES OF SUCH BUDGET AND ADOPTING A BUDGET FOR THE SUPPORT OF THE TOWN OF HOLLYWOOD PARK, TEXAS, FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2025 AND ENDING SEPTEMBER 30, 2026 AND ADOPTING THE ANNUAL BUDGET OF THE TOWN OF HOLLYWOOD PARK FOR THE 2025 – 2026 FISCAL YEAR AND PROVIDING A SAVINGS AND SEVERABILITY CLAUSE; REPEALING ALL ORDINANCES AND APPROPRIATIONS IN CONFLICT WITH THE PROVISIONS OF THIS ORDINANCE; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, a public hearing was ordered by the City Council of the Town of Hollywood Park, Texas and a public notice of said hearing was duly posted and published in the San Antonio Express/News in accordance with applicable state law and the City Council held a public hearing on September 16, 2025 in the Council Chambers; and

WHEREAS, the City Council finds that all provisions pertaining to the adoption of the budget contained in state law have been complied with; and

WHEREAS, after full and final consideration, the City Council is of the opinion that the budget is in accordance with state law in that the estimated expenditures will in no case exceed proposed revenues and said budget should be approved and adopted; and

WHEREAS, the Budget, appended here as Exhibit A, for the fiscal year beginning October 1, 2025, and ending September 30, 2026, was duly presented to the City Council by the Mayor;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF HOLLYWOOD PARK, TEXAS:

SECTION 1. That the appropriations for the fiscal year beginning October 1, 2025, and ending September 30, 2026, for the support of the general government of the Town of Hollywood Park, Texas, be fixed and determined for said term in accordance with the expenditures shown in the Town's Fiscal Year 2025-2026 Budget, a summary of which is appended hereto as Exhibit A.

SECTION 2. That the budget as shown in words and figures in Exhibit A, is hereby approved in all respects and adopted as the Town's budget for the fiscal year beginning October 1, 2025 and ending September 30, 2026.

SECTION 3. The City Council hereby authorizes the Mayor, and designated staff to sign documents authorizing the payment of funds, and to expend public expenditures that have been expressly approved and appropriated in this budget.

SECTION 4. That should any part, portion, or section of this ordinance be declared invalid or inoperative or void for any reason by a court of competent jurisdiction, such decision, opinion or judgment shall in no way affect the remaining portions, parts, or sections or parts of section of this ordinance, which provisions shall be, remain and continue to be in full force and effect.

SECTION 5. That all ordinances and appropriations for which provision has heretofore been made are hereby expressly repealed if in conflict with the provisions of this ordinance.

SECTION 6. This ordinance shall take effect and be in full force and effect on October 1, 2025, after its passage and approval according to law.


